



## IIUM OFFICIAL GUIDELINES DURING THE CONDITIONAL MOVEMENT CONTROL ORDER 02/2021

### MOVEMENT IN AND OUT OF CAMPUS FOR OFF-CAMPUS STUDENTS, VISITORS & THE PUBLIC

*\* This guideline is applicable to all Gombak, Kuala Lumpur and Pagoh campuses for the period of Conditional Movement Control Order 1<sup>st</sup>–14<sup>th</sup> April 2021.*

#### SECTION 1: INTRODUCTION

1. The Malaysian Government has announced to extend the Conditional Movement Control Order (CMCO) in Selangor, Kuala Lumpur, Johor, Kelantan and Penang from 1<sup>st</sup> to 14<sup>th</sup> April 2021.
2. IIUM is steadfast in ensuring the safety of the staff and students. Hence, the University takes the CMCO instructions by the Government very seriously.
3. The Malaysian government has begun to loosen the strict CMCO rules in many areas, however, the University believes that in the continuous fight against COVID-19, **success is much dependent on everyone's responsible behaviour, and being honest in ensuring the safety of oneself and others.**
4. The University strives to ensure the safety and welfare of the staff, students, visitors, and public who are involved with the activities in the University. In addition, the University is also very particular about the quality of education and other services provided.
5. Therefore, these guidelines are developed to determine the movement in and out of the Campus for off-campus students, visitors, and the public during the Conditional Movement Control Orders.
6. The effectiveness of these guidelines is highly dependent on the responsibility and honesty of everyone in complying with the regulations issued by the Malaysian government and also the University.

## SECTION 2: OFF-CAMPUS STUDENTS ENTERING THE CAMPUSES

1. Off-campus students are **allowed to enter** the campus if there is an urgent need to do so.
2. Off-campus students can enter the campus starting **5<sup>th</sup> April 2021** from **8 a.m. to 7 p.m.** daily and are not allowed to spend the night on campus.
3. Entry and exit must be through **GATE 2 OF GOMBAK CAMPUS, MAIN GATE OF KUALA LUMPUR CAMPUS AND MAIN GATE OF PAGOH CAMPUS.**
4. Students must install and activate the MySejahtera application in their smartphones.
5. Students must scan the MySejahtera QR code at every premises on campus that they visit.

### **SECTION 3: VISITORS AND PARENTS ENTERING THE CAMPUSES**

- 1.** Visitors and the public with specific purposes can enter the campus as per the prescribed time starting from **5<sup>th</sup> April 2021**.
- 2.** Visitors or the public are required to make an appointment before being allowed to enter the campus.
- 3.** Parents can enter the campus starting from **5<sup>th</sup> April 2021** from **8 a.m. to 7 p.m.**
- 4.** Entrance and exit routes for parents, visitors and the public are through **GATE 2 OF GOMBAK CAMPUS, MAIN GATE OF KUALA LUMPUR CAMPUS AND MAIN GATE OF PAGOH CAMPUS.**
- 5.** Parents, visitors, and the public must do the check-in and check-out at **GATE 2 OF GOMBAK CAMPUS, MAIN GATE OF KUALA LUMPUR CAMPUS AND MAIN GATE OF PAGOH CAMPUS.**
- 6.** Parents, visitors, and the public must install and activate the MySejahtera application in their smartphones.
- 7.** Parents, visitors and the public must scan the MySejahtera QR code at every premises on campus that they visit.

#### SECTION 4: CONCLUSION

1. IIUM urges all staff and students to always put their safety and the safety of their families and fellow colleagues as the main priority. This is necessary to minimise the risk of COVID-19 infection among staff and students, and their family members, as well as to ensure safe operation of the University.
